Re: Project Labor Agreement Status Report

The Project Labor Agreement (PLA) for the Transbay Program was approved on November 10, 2011. The PLA is designed to ensure labor harmony and equal opportunity for small, local, disadvantaged, union, and non-union businesses throughout construction, providing standardized working conditions and wages. This quarterly report provides information on the status of the administration of the PLA and the apprenticeship plan that was developed in conjunction with the PLA.

PROJECT LABOR/LABOR HARMONY/ ACCESS TO SKILLED LABOR POOL

No work stoppages or labor incidents have affected construction on the project. The Construction Manager/General Contractor (CM/GC) Webcor/Obayashi and its trade subcontractors have reported no issues accessing skilled labor in sufficient numbers, and each trade subcontractor's workforce demands have been met.

A breakdown of labor by trade and county of residence compiled through December 31, 2019, by Turner Construction, the TJPA's construction management oversight consultant, for the monthly construction update is shown in the two tables that follow:

Final Reports on Apprenticeship Programs/Utilization and Veterans Outreach Efforts

All union members present confirmed that interest in their apprenticeship programs remains strong. Jose F. Almanza (Electricians Local Union No. 6) reported that there were over 1,400 applicants at the last sign-up and testing is underway.

Discussion on PLA status after Webcor/Obayashi Joint Venture Final Completion

With regard to continuation of the Project Labor Agreement (PLA) during the lag between the completion of Phase 1 construction and the start of Phase 2, Dennis Turchon confirmed that the agreement specifically allows for the terms to apply to other construction work, such as tenant improvement work, after Phase 1 Final Completion. There were no objections from the attendees regarding the continuation of the PLA through the tenant improvement construction after the Phase 1 Final Completion milestone, and all comments were favorable to the motion. The tenant improvement contracts will continue to implement the PLA and the Harmony Letter going forward based on this general consent.

New topics & next meeting

Executive Director Zabaneh suggested discussing goals for Phase 2 at the next JAC meeting, and the union representatives were in agreement.
